#### ADVANTAGES OF DOVER GREEN:

**Removes Risk** – Simply put, contracting with Dover Green removes the risk of potential tax or other liabilities falling on you as an Agency when making gross payments to Dover Green. Dover Green has been established to facilitate the use and payment of Self-Employed individuals such that these individuals can be paid gross and will be required to manage their own tax affairs, removing the onus and risk of any tax responsibilities off the Agency.

**Saves Time and Administration** – Being able to make gross payments removes the need for you to administer a PAYE scheme for the self-employed contractors working through Dover Green.

**Lowers Costs** – If based in the United Kingdom, you need not pay Employer's National Insurance as you are no longer the employer.

**Improves Cash Flow** – There is no VAT on invoices as Dover Green is based in the Channel Islands which are outside the scope of UK VAT No

**Agency Worker Regulation (AWR) Requirements** – As contractors are self-employed, this legislation does not apply.

#### HOW DOES DOVER GREEN REMOVE RISK?

- Despite the self-employed nature of a particular contractor, many agencies prefer not to pay their contractors gross as there are risks of being found liable for not deducting tax at source as well as possible penalties regarding Managed Service Provider legislation.
- The relevant legislation is at Section 688A(1) ITEPA 2003, which states that: PAYE regulations may make provision authorising the recovery from a person within subsection (2) of any amount that an officer of Revenue and Customs considers should have been deducted by a managed service company ("the MSC") from a payment of, or on account of, PAYE income of an individual.
- Accordingly, our tax advisors have stated that since Dover Green is not deemed to be an MSC then Section 688A(1) ITEPA 2003 cannot apply. This means that UK Agencies will not be exposed to potential tax/NI liabilities if they contract with Dover Green.

#### WHAT CONTRACTUAL RELATIONSHIPS ARE INVOLVED?

- 1. The relationship you have with the end-client remains as is
- 2. Dover Green enters into a contract with you, the Agency
- 3. Dover Green enters into a contract with the contractor
- 4. The individual then becomes a self-employed worker being sub-contracted through Dover Green to you, the Agency, for work done at an end-client

#### WHAT IS THE PAYMENT PROCESS AND COSTS INVOLVED?

- 1. You invoice the end-client at the rate you agreed with them
- 2. Dover Green invoices you at the rate agreed with the contractor
- 3. Dover Green allocates 5% of each invoice value towards the cost of administration and makes a gross payment of the remainder to the contractor
- 4. The contractor is then required to submit their tax return and pay over any tax or other liabilities as Dover Green ensures that all UK based contractors register as self-employed

Online Storage of Receipts - Although self-employed individuals off-setting expenses against their income are required to retain all receipts for up to 6 years, Dover Green provides an upload facility where a photo or scan of any document or receipt can be stored and accessed on their personal account.

Financial Record Keeping Platform - Contractors' invoices are raised, paid and managed through their online account. They have the facility to record all relevant financial information relating to their work as a self-employed contractor (including income not paid through Dover Green).

Self-Assessment Assistance - While Dover Green is not a tax agent and cannot complete or submit a contractor's tax return on their behalf, the Financial Record Keeping Platform outputs the recorded information in a format that makes completing their Self-Assessment as simple as possible.

Important Reminders - Contractors are provided with live estimates of how much should be set aside for tax and other liabilities. They are also reminded and notified of any important deadlines regarding payments and returns.

Foreign Currency Payments - Dover Green is able to supply contractors globally and make payments in GBP, EUR or USD.

- · Read and Agree to the Dover Green contract (electronically via their online personal account)
